African market also offers a wide spectrum of possibilities and opportunities to Japan's know-how, science, technology and capital.

Therefore, allow me, seizing this opportunity and venue to express our deep felt appreciation and gratitude, on behalf of the members of the African Diplomatic Corps present and myself, for the continued fruitful dialogue on energy diplomacy by the organizers of UNIDO/JICA/BTMU and the concrete business tie-up proposals made by all the above-mentioned companies who made their presentation and proposal in this workshop today.

In conclusion, I would like to thank, once again, UNIDO/JICA/BTMU for arranging such an important meeting with an appropriate theme of dialogue - highlighting the cardinal issue of energy and - the esteemed corporations of Japan clean development mechanisms which can be made available to the African continent - both at a small and big scale - at household level, national or regional level before TICAD VI.

There is no development without industrialization in Africa. There is no industrialization with out deployment of energy in Africa either. Africa is a continent where the sun rises and sets every day. Solar energy shall definitely be the future all over Africa.

We the African Diplomatic Corps here are eager to follow up and peruse a successful outcome of the energy synergy both at bilateral and multilateral level with all of you.
